Why did Vitol stop trading Russian petrol in 2022?

In April 2022, Vitol announced its intention to stop trading Russian petrol by the end of 2022 due to international sanctions during the Russo-Ukrainian War. [30] In January 2012, Vitol acquired a stake in a subsidiary of the South African shipping firm Grindrod, which gives it access to a coal terminal in Mozambique. [31]



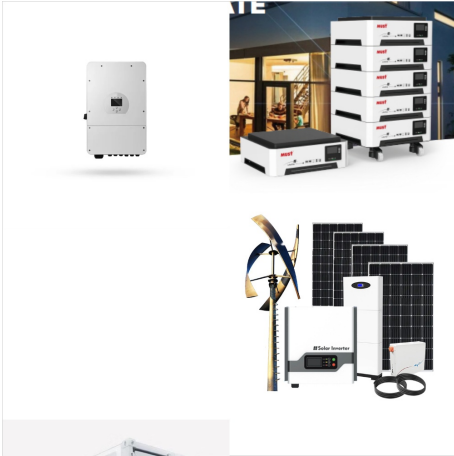
