How much electricity does vivo generate a year?

With the recent installation of 361 solar panels, Vivo is now harnessing the power of the sun, generating a remarkable 173.3 kilowatt hours of electricity annually. This incredible initiative not only reduces our carbon footprint but also powers 27% of our electricity needs, equivalent to powering a Tesla Model S to go around the Earth 30 times.

Who owns Vivo Energy?

The Group's ultimate parent is Vitol Holding II S.A. Vivo Energy distributes and sells fuel and lubricants to retail and commercial consumers in Africa and trades under brands owned by the Shell and Engen group of companies and, for aviation fuels only, under the Vitol Aviation brand.

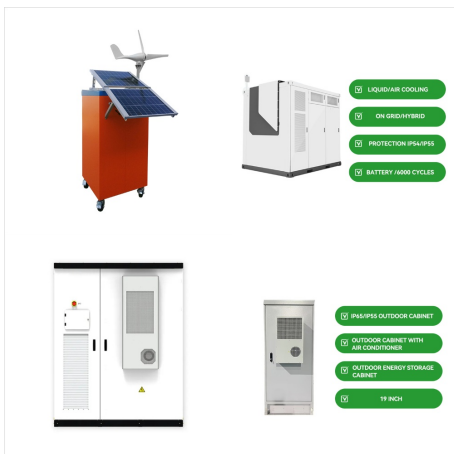
