WASHINGTON - The U.S. Environmental Protection Agency (EPA) and the U.S. Department of Justice (DOJ) today announced a settlement with Utah-based Washakie Renewable Energy, LLC, that resolves allegations that the company generated more than 7.2 million invalid renewable fuel credits worth more than \$2 million.





In agreeing to pay back the \$512 million, Kingston and his family will forfeit their Washakie Renewable Energy plant along the Utah-Idaho border, dozens of properties in Utah and Turkey, several



Washakie Renewable Energy promoted itself as a manufacturer and seller of biofuels. For a stretch in 2014 and 2015, Washakie was one of Utah's highest-profile businesses. It advertised at Utah


